**Players should report to the registration table one half (1/2) hour before their scheduled starting time.**

**ENTRY FORM:** Members must complete this official entry form or register online at [www.mwpga.org](http://www.mwpga.org).

**ELIGIBILITY:** Entries are open to female amateur golfers who: (1) are members of a MWPGA league prior to the Match Play Championship entry close date, and (2) have a current 18-hole USGA Handicap Index, computed under the GHIN system not exceeding 40.4 at the close of entries. The USGA definition of an amateur golfer is the standard of the MWPGA. All entries are subject to approval or rejection at any time by the Tournament Committee. Please contact your course to ensure it is an MWPGA league.

**FORMAT:** This tournament is an 18-hole match play format with consolation rounds. Contestants shall discontinue play when their match is decided. All players will be eligible at minimum to participate in matches on both Friday and Saturday.

**FLIGHTS:** The tournament committee will determine flights after the close of entries. Any ties in handicap indexes for the final flight position will be decided by a blind draw.

*If there are more than 8 players registered with a handicap index of 5.9 or less, there will be 16 players placed in the Championship Flight, seeded by handicap indexes on Friday. There will then be double rounds on Saturday (morning and afternoon) for the Championship Flight and Championship Consolation. All finals will be on Sunday.*

**HANDICAP INDEX:** The handicap index used for the event is the most current revision when flights are determined.

**FIELD LIMITATION:** The field will be limited to 80 players with the lowest USGA handicap index. Entries in excess of 80 will be held on an alternate list. Applicants will be notified if they are put on the alternate list.

**TIES:** In the event of a tied match, the winner shall be determined immediately by a hole-by-hole playoff restarting at Hole #1 with the stipulated round being extended to as many holes as are required for the match to be won.

**STARTING TIMES:** Players will be notified of starting times by mail or email. Starting times for Friday matches will begin at 1:00 p.m. Starting times for Saturday and Sunday matches will begin at 8:00 a.m.

**CARTS AND CADDIES:** Motorized carts, battery operated hand carts and pull carts are permissible. Requests for motorized carts must be made on this entry form with payment to be made by the player to the course on the event day. Caddies will not be available, but players may provide their own.

**PRACTICE ROUNDS:** Call the golf shop for availability. (See subsequent Notice to Competitors and/or [www.mwpga.org](http://www.mwpga.org) for tournament course yardage, slope and rating.)

**PRIZES:** Flight winners will receive merchandise certificates at the conclusion of tournament play.

**ENTRY DEADLINE:** Entry forms *including payment* must be received by 4:30 p.m. on the tournament entry close date. Enclose one entry per envelope. No phone or fax entries. Late or incomplete entries are not acceptable. Any fee incurred by the MWPGA resulting from insufficient funds check, along with the entry fee, must be paid before entry into further MWPGA events is allowed.

**ENTRY WITHDRAWAL AND REFUNDS:** Your entry fee, minus a \$15 administration fee, will be refunded if the MWPGA is notified before the close of entries. **Fees will not be refunded after the close of entries.**
